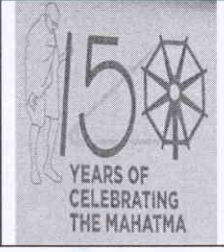

Tender Details: The tender Documents shall be submitted in two covers:

Cover 1: Shall contain scanned copies of all "Technical Documents/Eligibility information".

Cover 2: Shall contain "BOQ/Financial Bid", where the contractor will quote the offer for each item.

- (a) Submission of Original Documents: The bidders are required to submit (a) original demand draft towards the cost of bid document and (b) original bid security/Earnest Money deposit (EMD) and other technical documents in the O/o Director IIIT Una, as specified in the key dates of **Sr. no. 2** on tender opening dates & schedule, failing which the bids will be declared non-responsive. EMD in the form of DD/FDR/Banker Cheque /Bank Guarantee must be attached in favour of Director, IIIT, Una (H.P). The EMD should be valid for a period of 60 days beyond the final bid validity period.

EMD of unsuccessful bidders shall be returned after the expiry of the final bid validity or before the 30th day of the award of contract. The EMD of the successful bidder shall be released after receipt of a performance security for the warranty/guarantee period of equivalent amount. The above condition is applicable to all and no relaxation will be given.

3. **BID OPENING DETAIL:** The bids shall be opened as per schedule specified in the key dates of **Sr. no.3.** in the office of Director IIIT Una Camp Office at NIT Campus, Hamirpur. In their interest the tenderers are advised to be present along with original documents at the time of opening of tenders. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
4. The Contractor should possess required valid electrical license from Chief Electrical Inspector Shimla and should fulfill the required work experience as per term and conditions at Sr. No. 5.
5. The bidder must have successfully completed at least one similar work of same nature of value not less than estimated cost or two electrical works each of value not less than half the estimated cost during the last three years. The bidders shall have to produce supporting documents giving date of award, date of commencement and completion from the concerned competent authority (Rank not less than Executive /Assistant Engineer).
6. The bids for the work shall remain valid for acceptance for a period of not less than 90 days after the deadline date for bid submission. Other details can be seen in the bidding documents. The Employer shall not be liable for any information not received by the bidder. It is the bidders responsibility to verify the website for the latest information related to the tender.
7. The copy of enlistment order and renewals, Copy of PAN issued by Income Tax Department and copy of Sale Tax Registration Certificate, GST, etc., must be attached in the cover-1.
8. The bidder must have successfully completed at least one work of similar nature in Govt. deptt. during the last three years. The bidders shall have to produce supporting documents giving date of award, date of commencement and completion from the concerned competent authority and should be included in cover-1.
9. Destination: F.O.R. destination, i.e., Transit Campus of IIIT Una Dev Bhumi, Group of Institutes, Chandpur, Haroli, Una-177220.
10. CST/ST/GST/PAN/TIN Nos., etc., All the firms may invariably mention their CST/ST/PAN/TIN numbers on tender failing which tenders may not be considered valid. Further, this Institution does not issue any C/D Concessional form, so the GST applicable the rates shall be quoted as inclusive of all taxes.

13. The jurisdiction of the law of court shall be at Una/ Hamirpur/Shimla (HP) only.

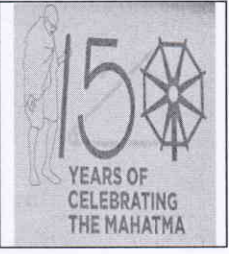

TERMS AND CONDITIONS:

- Validity:** Minimum validity of the quoted rates will be 03 months from the date of opening of the quotation/tenders.
- Time Limit:** The firm/contractor has to complete the job within two months from the date of the award letter.
- Guarantee/warranty:** The contractor has to provide guarantee/warranty for next 01 year from the date of successful installation of the job executed.
- The Contractor should possess required valid electrical license from Chief Electrical Inspector Shimla and should fulfill the required work experience as per term and conditions at Sr. No. 5.
- The bidder must have successfully completed at least one similar work of same nature of value not less than estimated cost or two electrical works each of value not less than half the estimated cost during the last three years. The bidders shall have to produce supporting documents giving date of award, date of commencement and completion from the concerned competent authority (Rank not less than Executive /Assistant Engineer).

6. **EMD: EMD in the form of DD/FDR /Bank Guarantee must be attached in favour of Director, IIIT, Una at NIT, Hamirpur (H.P) -177 005.** The EMD should be valid for a period of 60 days beyond the final bid validity period. EMD of unsuccessful bidders shall be returned after the expiry of the final bid validity or before the 30th day of the award of contract. The EMD of the successful bidder shall be released after receipt of a performance security for the warranty/guarantee period of equivalent amount. The above condition is applicable to all and no relaxation will be given.
7. **Performance Bank Guarantee:** The supplier will have to submit performance bank guarantee @ 10 % within 10 days from the date of issue of supply order failing which the supply order will be cancelled. The PBG should remain valid during the warranty period and the same will be released after the expiry of warranty period and submission of fresh PBG @ 5 % of the quoted value which should remain valid for the free service period.
8. **Penalty clause:** In case of delay beyond job completion period penalty @ 2% for the first 20 days will be imposed, thereafter penalty @ 5 % for the next 20 days & finally penalty @ 10% for the next 20 days will be imposed. Maximum delay along with penalty for 60 days is tolerable and beyond that the order will be cancelled and PBG will be forfeited and the supplier will be de-barred to participate in any of the tenders of IIIT, Una for a period of Five Years.
9. **Destination:** F.O.R. destination i.e. Transit campus of IIIT Una (HP), i.e., Dev Bhumi Group of Institutes, Chandpur, Haroli, Una and the rates must be quoted inclusive of all taxes and charges.
10. **Price/Rate:** The price of equipment/items may be quoted indicating all taxes in Indian rupees as per BOQ. Tender will be awarded to the bidder who will be the lowest in terms of total of all items.
11. CST/ST/GST/LST/PAN/TIN Nos. etc. All the firms may invariably mention their CST/ST/LST/PAN/TIN numbers on tender failing which tenders may not be considered valid. Further, this Institution does not issue any C/D Concessional form, so the GST applicable the rates shall be quoted as inclusive of all taxes.
12. **NIT/NIQ Opening:** Representative of the firm may be present at the time of opening of the Quotations, if the contractor wishes.
13. **Payment:** 100% payment shall be made immediately after successful completion of job. (Certificate of the same to be given by the indenter/inspection committee IIIT, Una).
14. **Right of Acceptance/Rejection:** Right of acceptance and rejection of any tender/quotation in part or full without assigning any reason are reserved with the institution authorities. The quantity of items to be supplied could be increased or decreased depending on the requirement of end user.
15. In case of any dispute the jurisdiction of Una (HP) Courts shall apply.

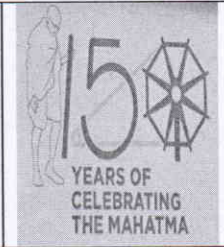
