4.	B.Tech. (2020-24)	4 <sup>th</sup> Year VIII Semester	Rs.1,00,500/-

- The semester fee will be accepted through online SBI i-Collect and fee payment window is; 04, Nov.'23 – 07, Jan'24.
- A late fee has to be additionally paid for payment beyond the deadline of 07, Jan'24 as per the following details:
  - Within one week : Rs. 1,500/-
  - Within two weeks : Rs. 3,000/-
  - Within three weeks : Rs. 6,000/-
  - Within four weeks : Rs. 9,900/-
  - Beyond four weeks : Not registered for the whole semester and has to REDO the course along with juniors.
- The fee payment window is fixed for those students availing Bank Loan, Scholarship, etc.
- The students who intend to deposit the fee through DD on account of their education loan are advised to request their Banks to deposit the same through Online SBI i-Collect to IIIT, Una or submit Demand Draft in favor of Director, IIIT Una of any scheduled Bank located at Una (HP).

### **SBI i-Collect Step by Step Procedure for Payment of Institute Fee**
