2.	B.Tech. (2022-26)	3 <sup>rd</sup> Year V Semester	Rs.1,20,000/-
3.	B.Tech. (2021-25)	4 <sup>th</sup> Year VII Semester	Rs.1,02,050/-

The details of the fee components are attached herewith.

1. The semester fee will be accepted through online SBI i-Collect and fee payment window is; 01, June'24 – 07, July'24.
2. A late fee has to be additionally paid for payment beyond the deadline of 07, July'24 as per the following details:
  - a) Within one week : Rs. 1,500/-
  - b) Within two weeks : Rs. 3,000/-
  - c) Within three weeks : Rs. 6,000/-
  - d) Within four weeks : Rs. 9,900/-
  - e) Beyond four weeks : Not registered for the whole semester and has to REDO the course along with juniors.
3. The fee payment window is fixed for those students availing Bank Loan, Scholarship, etc.
4. The students who intend to deposit the fee through DD on account of their education loan are advised to request their Banks to deposit the same through Online SBI i-Collect to IIIT, Una or submit Demand Draft in favor of Director, IIIT Una of any scheduled Bank located at Una (HP).
